# PRIVACY POLICY

We, BAO Capital Partners Ltd, are a Cyprus based Alternative Investment Fund Manager, licensed and regulated by the Cyprus Securities and Exchange Commission under Licence Number: AIFM16/56/2013. We are committed to protecting and respecting your privacy regarding any information we might collect while operating our websites.

Our Privacy Policy is designed to ensure compliance with the Processing of Personal Data (Protection of the Individual) Law of 2001. In Cyprus, 'The Processing of Personal Data (Protection of the Individual) Law of 2001' (138 (I) 2001) regulates the collection, the process and the use of personal data. The particular law entered into force in 2001 in order to address privacy issues related to collection, storage, processing, dissemination and use of personal data. Furthermore, the Law was amended in 2003 so that to harmonise the Cyprus legislation with the EU Directive 95/46 on the protection of individuals regarding the processing of personal data.

At BAO Capital Partners Ltd we have two fundamental principles:

- 1. We don't ask for personal information unless we need it for improving the services offered to our clients.
- 2. We don't share personal information with anyone except to comply with the law, develop our services and products, or protect our rights.

Below is presented our privacy policy which incorporates these goals:

## **Website Visitors**

BAO Capital Partners Ltd may collect non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. # 1. Information you provide to us

#### 3. Information we receive from other sources

We are also working closely with third parties (including, for example, business partners, sub-contractors in technical, payment and delivery services, advertising networks, analytics providers, search information providers, credit reference agencies) and we may receive information about you from them.

#### **USE OF PERSONAL INFORMATION**

We, at BAO Capital Partners Ltd may use your personal information to:

- administer this website;
- personalize the website for you;
- enable your access to and use of the website services;
- send to you statements and invoices;
- collect payments from you;
- send you marketing communications; and
- send you the regulatory investor's information updates

#### **SECURING YOUR DATA**

We, at BAO Capital Partners Ltd, will take reasonable technical and organisational precautions to prevent any loss, misuse or alteration of your personal information. All the personal information you provide will be stored on our secure servers. BAO Capital Partners Ltd takes all measures reasonably necessary to protect against the unauthorized access, use, alteration or destruction of potentially personally-identifying and personally-identifying information.

## **DISCLOSURE OF YOUR INFORMATION**

We may share your personal information with any member of our group, which means our subsidiaries, our ultimate holding company and its subsidiaries, as defined in the Companies Law Cap. 113 (as amended from time to time).

We may share your information with selected third parties including:

- Business partners, suppliers and sub-contractors for the performance of any contract we enter into with them or you. Advertisers and advertising networks that require the data to select and serve relevant adverts to you and others.
- Analytics and search engine providers that assist us in the improvement and optimisation of our site.

#### **CROSS-BORDER DATA TRANSFERS**

Information that BAO Capital Partners Ltd collects may be stored and processed and

transferred between any of the countries in which we operate or we cooperate with, to enable the use of the information in accordance with this privacy policy.

# PROTECTION OF CERTAIN PERSONALLY-IDENTIFYING INFORMATION

BAO Capital Partners Ltd discloses potentially personally-identifying and personally-identifying information only to those of its employees, contractors and affiliated organizations that:

(i) need to know that information in order to process it on BAO Capital Partners Ltd behalf or to provide services available at BAO Capital Partners Ltd websites,

and (ii) that have agreed not to disclose any such information to others by signing our non-disclosure agreements.

Some of those employees, contractors and affiliated organizations may be located outside of your home country. By using BAO Capital Partners Ltd websites, you consent to the transfer of such information to them. BAO Capital Partners Ltd will not rent or sell potentially personally-identifying and personally-identifying information to anyone.
